

# Breeder Reward Scheme - Terms & Conditions



In these Terms & Conditions and Business Rules:

- Reference to “we” and “us” means Agria Pet Insurance
  - Reference to “you” means the Breeder being a member of the Reward Scheme
  - Reference to “the Scheme” means the Agria Breeder Rewards Scheme
  - “Redemption date” is the date at which the number and value of qualifying rewards are calculated
1. Breeders who receive cash payments may be liable for tax. It is the responsibility of the breeder to make appropriate declarations to HM Revenue & Customs.
  2. Cash payments are not transferable.
  3. Agria Pet Insurance has the right, without notice or liability to any member, to:
    - Stop the Scheme at any time,
    - Change the type of payment or reward,
    - Change the amounts or frequency of reward payments,
    - Remove any items included in the Scheme,
    - Change these terms of business.
  4. Payment will be made directly to the bank account details provided by the breeder and which are held at the redemption date.
  5. The breeder is obliged to provide bank details where payments are to be made – if payments details have not been provided within 6 months of the redemption date, any accrued rewards outstanding will be paid to our nominated charity and the breeder will lose the right to any monies.
  6. Redemption dates for the Scheme are March 1st and September 1st and these dates will continue on an annual basis. Payments will be made within 30 days of the redemption date.
  7. You must have enrolled and been accepted onto the Scheme in advance of your first Five Weeks Free activation to qualify for rewards payments.
  8. The Scheme is only available to breeders who reside in the UK.
  9. Agria Breeder Rewards Scheme applies to annual policies where;
    - the policy title is in the new owner’s name,
    - at least two month’s premiums have been paid,
    - annual cover is started immediately after the end of the Five Weeks Free cover note with no break in cover,
    - the insured pet is the same pet covered by the cover note.
  10. Agria Pet Insurance has the right to refuse to accept a breeder on the Scheme, or remove a breeder from the Scheme at any time.
  11. Breeders, who misuse this Scheme, do not adhere to the Terms and Conditions or do not follow the Terms of Business of the Five Weeks Free cover may have the facility withdrawn immediately, no further payments will be made and we may look to recover any costs.
  12. Five Weeks Free cover activations must be made online to qualify for breeder rewards – we will not include telephone activations
  13. The Scheme does not oblige Agria Pet Insurance to offer cover to a pet owner for either Five Weeks Free or annual cover.
  14. All communication will be via email - if no email address is provided, we will be unable to confirm in writing the amount paid.
  15. If you do not enrol into the Breeder Reward Scheme you will not earn any rewards.
