

Prize Draw Terms and Conditions – Crufts tickets prize draws

These terms and conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Participants of the promotion agree to be bound by these terms and conditions.

1. This prize draw is open to residents in the UK, Channel Islands and Isle of Man who are aged 18 years or over who meet the terms and conditions to qualify. Employees of Agria Pet Insurance are not eligible to enter.

7. The winners will be contacted as soon as possible via Facebook comment and message and will be asked to contact the Promoter by email to claim the prize and confirm delivery details for their tickets.
8. The winners will be offered a choice of ticket allowing entry to Crufts on certain days (Thursday/Friday or Saturday/Sunday-any day) and we will aim to fulfil preferences where possible but cannot guarantee this.
9. By entering the competition, you acknowledge the promotion is in no ways sponsored, endorsed, administered by, or associated with Facebook.
10. Your personal data will not be shared with any third parties and your marketing preferences will be unaffected by entering this prize draw.
11. Should the Promoter be unable to contact the winner or should the winner be unable to accept the prize, the Promoter reserves the right to award the prize to an alternative winner, drawn in accordance with these terms and conditions.
12. All elements of the prize are subject to availability, non-transferable and there are no cash alternatives.
